1. Introduction to Equalities Impact Assessment (EqIA)

- 1.1 All local planning authorities are required to produce a set of documents collectively known as the 'Local Plan' which outlines the main ways in which Derby will grow and change in the years 2023-2043. It sets out a vision for the future of the City, with the overall aim of ensuring that Derby is a vibrant, prosperous and sustainable place to live, work and visit for years to come.
- 1.2 The current Local Plan was adopted in July 2017 and sets out Derby's growth strategy through to 2028. After the commencement of its review in 2022, it was concluded that whilst several of its policies still continue to work effectively, a full new Local Plan is required.
- 1.3 The Equality Act 2010 sets out the Public Sector Equality Duty (PSED), which generates a requirement for public authorities to allocate due regard to certain equality considerations, in carrying out their functions. Whilst the Act does not require an Equality Impact Assessment (EqIA) to be produced, the presence of such an assessment acts as a key form of evidence that the PSED has been complied with effectively.
- 1.4 The purpose of this EqIA is to highlight the likely impact of the Local Plan for Derby on several identified characteristic groups, as well as identifying the actions required, where necessary, to improve the policies.
- 1.5 The Equality Act 2010 recognises a defined list of personal characteristics which are recognised under the law as requiring statutory protection. These factors are listed below, with their accompanying definitions:
 - Age: the protected characteristic of age refers to individuals of a particular age group, or a group of individuals belonging to the same age group
 - Disability: this protected characteristic refers to individuals with a physical or mental impairment, which has a substantial or long-term adverse effect on that individual's ability to carry out normal day-to-day activities
 - Sex: this protected characteristic is a reference to a man or woman.

- Gender Reassignment: this protected characteristic refers to individuals who are proposing to undergo, is undergoing, or has undergone a process (or part of a process) for the purpose of reassigning the person's sex by changing physiological or other attributes of sex.
- Marriage and Civil Partnership: this protected characteristic refers to individuals who are married or a civil partner.
- Pregnancy and Maternity: this protected characteristic refers to being pregnant, while maternity relates to the period after giving birth.
- Race: this protected characteristic refers to the race: colour, nationality, or ethnic and national origins of an individual.
- Religion and Belief: this protected characteristic refers to an individual's religion, lack of religion, or any other means of religious or philosophical beliefs.
- Sexual Orientation: this protected characteristic refers to an individual's sexual orientation towards persons of the same sex, persons of the opposite sex, or persons of either sex.

1.6 An additional factor of Income Equality has been included in the protected characteristics list used to conduct this EqIA, to ensure that the social harm caused by inequities relating to income levels, are adequately assessed. In particular, this factor aligns with Derby City Council's objective to provide an increased volume of affordable housing for lower-income households within the City of Derby.

2. Local Plan Preparation and Milestones

2.1 The process for preparing the new Local Plan has been quite lengthy and has involved a number of key stages (see diagram below).

- 2.2 Derby City Council have undertaken an initial round of public consultation to identify both the key issues and opportunities for the new Local Plan for Derby. This consultation took place in Spring 2024 for 6 weeks and provided an anonymous survey for respondents to complete. - 2.3 A previous version of the EqIA was published as part of the Regulation 18 Consultation, in which Derby's residents, businesses and key statutory consultees were invited to make comments on the Local Plan for Derby and its policies. No comments were received about the EqIA.
- 2.4 This is the Regulation 19 EqIA document, which has been updated to take account of any changes made to policy, in regard to the Regulation 18 Consultation.

- 2.5 This updated document is considered to be ready for Consultation under Regulation 19; however, it is important to note that this is a live document that will likely be amended as the Local Plan continues to develop.
- 2.6 Each stage will provide the community and other key stakeholders with the opportunity to become involved in selecting the right strategy and planning policies for Derby. Additionally, it will encourage the Council to consider the significant implications, on various different groups of individuals, associated with delivering the Local Plan.
- 2.7 There are several fundamental priorities of the new Local Plan for Derby to promote equality and community cohesion, improve the safety and accessibility of the city, and celebrate diversity by improving representation of various cultures. The process which the Council has undertaken to produce the Local Plan has been intended to generate policies which will implement these objectives. Furthermore, the plan is required to meet the City's housing and employment needs by allocating land for development. Key objectives of the plan, in terms of equalities are as follows:
- To enhance Derby as an attractive, vibrant and compact liveable City fully accessible by active travel, which has a strong City Centre of regional importance, regenerated urban areas and locally distinct neighbourhoods.
 - To support the development of balanced communities by ensuring that new, well designed, sustainable residential development helps to meet the city's housing needs sustainably and continue to work with neighbouring authorities to make the best provision for unmet need.
 - To increase the opportunity for people to socialise, play, be physically active and lead healthy lifestyles through a network of high quality, safe and accessible green infrastructure, sporting facilities, walking and cycling and wheeling routes to help Derby become one of the most active cities in the country, and tackle health challenges.
 - To promote equality and community cohesion, healthy and active lifestyles and support improvements in community safety, particularly for children and young people.
 - To strengthen the range and quality of Derby's cultural and learning opportunities and facilities by celebrating diversity, ensuring that the role of culture in the economy is better understood.

2.8 The new Local Plan has also been subject to an iterative process of Sustainability Appraisal (SA), which considers the social, environmental and economic implications of the policies produced. The primary purpose of this is to promote ‘sustainable development’ to effectively meet the needs of the City’s population. The SA also contains a number of objectives that are pertinent to the consideration of equality, including:

- To build inclusive communities by reducing social exclusion, reducing deprivation, promoting equity, equality and respecting diversity, improving local accessibility to healthcare, education, employment, retail facilities and recreational resources (Including open spaces and sports facilities)
- To improve health and wellbeing and reduce health inequalities, improving quality of life for all
- To deliver economic growth and support the creation of new and retention of existing businesses
- To create greater employment opportunities, higher value jobs and access to training
- To reduce crime and the fear of crime for all residents inclusively, improving safety
- To provide everybody with access to an affordable home which is resilient to the effects of climate change
- To provide better opportunities for people to participate in cultural, leisure and recreational activities
- To protect and improve biodiversity, geo-diversity, including protect and enhance favourable conditions on SSSI’s, SPA’s, SAC’s and other wildlife sites and improve connectivity between, and access to, green spaces and functional habitats
- To protect and enhance the character and appearance of the landscape and townscape, including landscape and townscape assets, as well as the area’s other natural assets and resources
- To conserve and enhance the historic environment, heritage assets (including known and unknown archaeological sites) and their settings and maintain and enhance access to cultural heritage for enjoyment and educational purposes
- To maintain good local air quality and to minimise noise and light pollution
- To ensure sustainable management of water resources and to minimise the risk of flooding
- Adapt to the effects of climate change including flood risk, extreme weather and overheating, and strengthen climate resilience
- To reduce the contribution towards the emission of greenhouse gases

- To reduce the number of journeys made by car, within and to and from the area and improve access to jobs, services and facilities
- To minimise water and soil pollution and ensure protection of natural resources including greenfield land, soil and minerals resources
- To minimise the generation of waste and effectively manage waste that is created

2.9 While the EqlA is more broadly based than the SA, there is considerable synergy between the two. The policies assessed within this document have been produced through an extensive and iterative process, which has involved refining the policies based upon the issues raised during the consultation period.

3. Scoping

3.1 An initial screening of the policies was undertaken, to identify the degree of relevance to each of the equality factors, as well as whether there is a requirement for an Impact Assessment to be conducted. It was concluded that a number of the proposed policies may have significant impacts upon one or more of the defined equality factors, and therefore an Impact Assessment was carried out.

4. Assessment

4.1 Each policy was considered against the identified equality factors for its potential impact, using a colour scoring system for adverse/neutral/positive impact. In cases where a negative or positive impact was identified, comments were made detailing the particular effect. This was considered appropriate due to the high-level strategic nature of the Local Plan, as well as the likelihood of individual policies impacting the specific identified groups. Although a number of the proposed policies were identified as having a neutral impact on the selected equality factors, they were included within the table to ensure completeness.

5. Conclusions

- 5.1 The assessment did not identify any particular concerns regarding negative impacts of the policies on specific sectors of the community. The extensive consultation and assessment processes which the Council undertook helped to ensure this occurred. The Policies have evolved over time in response to any concerns raised, leading to the adoption of appropriate mitigation measures.
- 5.2 It is fundamental to note that the underlying objectives of the Local Plan and the SA have been in place from an early point within the plan making process, and thus the policies have been drafted to ensure that they remain consistent with these aims. The Council acknowledge that the policy framework produced does not have any unacceptable impact on equalities.

6. Monitoring and Review

- 6.1 Both the Local Plan and SA contain suggested monitoring regimes to ensure that the policies are being delivered effectively. It is important to note that these monitoring indicators are not yet finalised and may evolve as the Local Plan for Derby develops. Of particular relevance to the impact on equalities will be:
- Indices of Multiple Deprivation
 - Number of Primary and Secondary Schools within the Derby City Boundary
 - Key Economic Areas (i.e. Retail Parks, District Centres)
 - Designated Open Spaces (i.e. Amenity Green Space, Parks, Allotments)
 - Designated Wildlife Sites (i.e. Semi Natural Land, TPOs, LNR)
 - Key Landscape and Townscape Features
 - Heritage Assets (i.e. Listed Buildings, Historic Parks, and Ancient Monuments)
 - Air Quality Management Areas
 - Waterbodies (i.e. Open Watercourses, Culverted Watercourses, and Canals)
 - Flood Risk Areas and Flood Defences

- Risk of Surface Water Flooding
- Transport (i.e. Bus stops, Railway Lines and Stations)
- Agricultural Land Classification
- Waste Sites within the Derby City Boundary

6.2 The results of this monitoring will be published in the annual Authority Monitoring Report following adoption of the new Local Plan.
