Supplementary Statement 02

This supplementary statement has been prepared and issued by the Derby and Derbyshire Joint PNA Steering Group on behalf of the Derby City and Derbyshire County Health & Wellbeing Boards, in accordance with the requirements set out under the National Health Service England (Pharmaceutical Services and Local Pharmaceutical Services) Regulations 2013 (SI 2013 No. 349) and amended in 2014, 2015 and 2016 [“the Regulations”]. The statement has been issued in accordance with Part 2; 6 (3) of the Regulations and updates the [Pharmaceutical Needs Assessment \(PNA\) 2018-2021](#) published by the aforementioned Council’s on 26th March 2018. The updated information that follows supersedes some of the original information contained within the PNA and should be read in conjunction with that document and Supplementary Statement 01. Changes noted reflect those that have occurred between the dates of 1st July 2018 and 30th September 2018.

Table 2 highlights the change in number and rate of community pharmacies per 100,000 head of total population. In June 2018 the Office for National Statistics (ONS) published the mid-2017 population estimates for UK, England and Wales, Scotland and Northern Ireland¹ which updates the previously published mid-2016 figures used in the PNA 2018-21. Taking into account these and the cumulative changes to provision since publication of supplementary statement 01; Amber Valley, Bolsover, Erewash and Derby City have seen a reduction of one pharmacy per 100,000 population. Amber Valley, Erewash and Derby have seen a physical reduction of one pharmacy while growth in Bolsover's population has outweighed any change to existing provision. There has been no overall change to the rate of provision across the Derbyshire STP area.

Pharmacy opening hours

Pharmacies are able to apply to NHS England for changes to core opening hours, or notify them of changes to additional supplementary opening hours, throughout the year. Since publication of the PNA in March 2018 there have been a number of changes to individual pharmacy opening times. Pharmacies are required to keep their NHS UK entries up to date. At the end of September 2018 there had been a physical reduction of three pharmacies across the Derby and Derbyshire area. Whilst this is minimal and the one closure and two consolidations approved on the basis that they do not impact upon access, it is important to also consider the impact on reduced hours of availability throughout the week. A pharmacy normally has 40 core contractual hours (or 100 for those that have opened under the former exemption from the control of entry test)². They will each open for additional, supplementary hours throughout the week depending on need. Changes to core opening hours cannot be made without approval from NHS England, while changes to supplementary hours can be made by the pharmacy at any point subject to giving three months' notice.

At time of publication of the PNA 2018-21 there were over **10,000** core hours of pharmacy provision available to the population each week. The recent reduction in premises has removed **180** hours (**2%** of overall hours) per week. A more detailed analysis of impact throughout 2018/19, including changes to supplementary hours, will take place at year end.

Changes to service provision

Pharmacy First (Minor Ailment Scheme) and Self-care Campaign

The Pharmacy First scheme which had been available in Southern Derbyshire and Erewash CCG areas was fully decommissioned in October 2018. A Self-Care Policy was introduced across Derbyshire in December 2017 which has been promoted locally with a self-care campaign launch in August 2018. The 'Be Self-Care Aware' campaign promotes how self-care is quick, easy, simple and considerate and encourages people to self-treat minor conditions by purchasing over the counter medicines instead of visiting their GP. The approach to the campaign is a transformational one; aiming to improve health literacy, provide appropriate signposting as well as offering the population support on how to self-care as well as how to prepare to self-care. Digital Minor Illness Referral Service (DMIRS)

The NHS Digital Minor Illness Referral Service (DMIRS) is an Enhanced Service as defined by Part 4 paragraph 14(1)(j) - of the Pharmaceutical Services (Advanced and Enhanced Services) (England) Directions 2013 (as amended). It is a pilot service funded by NHS England Pharmacy Integration Fund until end March 2019.

The purpose of DMIRS is to reduce the burden on urgent and emergency care services by referring patients requiring low acuity advice and treatment from the NHS 111 non-emergency medical helpline to community pharmacy. Its aim is to ensure that patients have access to the same if not better levels of care, closer to home and with a self-care emphasis. The agreement is for the pharmacy to provide self-care advice and support, including printed information, to all individuals referred to the pharmacy by NHS 111 on the management of specified low acuity conditions.

The aims and intended outcomes of DMIRS, include:

- To test full integration of community pharmacy into the urgent care system as a provider of care for patients currently referred to other parts of the urgent care system;
- To relieve pressure and create capacity in other parts of the urgent care system, particularly for higher acuity clinical conditions;
- To test the quality and effectiveness of clinical urgent care services provided by community pharmacy;
- To reduce demand on the rest of the urgent care system, particularly GP Out of Hours (OOHs) providers and Walk-in Centres;
- To enable convenient and easy access for patients and for NHS111 health advisor referral;
- To reduce the use of primary medical care services for the referral of minor illness from NHS 111;
- To identify ways that individual patients can self-manage their health more effectively and to recommend solutions that could prevent use of Urgent and Emergency Care in the future;
- To increase patients' awareness of the role of community pharmacy as the 'first port of call' for low acuity conditions;
- To be cost effective for the NHS when supporting patients with low acuity conditions.

DMIRS went live across the East Midlands geography covered by DHU Healthcare Ltd as the NHS 111 provider, on 6th November 2018. 128 community pharmacies in Derbyshire have signed up with the NHS Business Services Authority (BSA) to provide the service.

It is anticipated that Supplementary Statement 03 will be published in January 2019 unless any significant change to provision should occur in the interim months.
