## Who we are?

Derby Connected is run by Derby City Council who is the local government unitary authority for Derby City. Our address is The Council House, Corporation Street, Derby, DE1 2FS. ## How do we collect information from you?

We collect information from you when you visit [www.derbyconnected.com](http://www.derbyconnected.com) also when you contact us in writing, speak to us on the phone, by email or any other type of electronic communication, or talk to us face to face.

## What types of information do we collect from you?

We collect different categories of information about you, depending on the service you want from us and/or the reason why we need to process information relating to you. This could be personal information (for example your name and address), or other more sensitive data that we would only collect and use in very particular circumstances that are set out in law.

## How is your information used?

Where we have your consent we may use your information to:

- *Send you communications which you have requested and that may be of interest. This may include information on travel campaigns, events and promotions*
- *to carry out our obligations arising from any contracts (i.e. business grants) entered into by you and us,*
- *notify you of changes to our service offerings*
- *deal with entries into a competitions*
- *seek your views or comments on the services we provide*

Anonymised & Pseudonymised data may be used for research & Statistical purposes. Any Data collected may be used for research and statistical purposes that are relevant and compatible with the purpose that the data was collected for.

## Who has access to your information?

We may share your information with the following third parties for the reasons detailed;

- [Mailchimp](#) – *we use Mailchimp to send our newsletters and eshots. The email address you provided when you signed up to receive these emails is held on servers within Europe. Your email address will only be used to send you communications relating to Derby Connected and Derby City Council. You can view Mailchimp's [privacy policy](#) on their website*

We will not sell or rent your information to third parties. We will not share your information with third parties for marketing purposes.

## What are your rights in relation the personal data we process?

**Access** – you can request copies of any of your personal information that is held by the Council.

**Rectification** – you can ask us to correct any incorrect information.

**Deletion** – you can ask us to delete your personal information. The Council can refuse to delete information if we have a lawful reason to keep this.

**Portability** – you can ask us to transfer your personal data to different services or to you.

**Right to object or restrict processing** – you have the right to object to how your data is being used and how it is going to be used in the future.

**Right to prevent automatic decisions** – you have the right to challenge a decision that affects you that has been made automatically without human intervention, for example an online form with an instant decision.

**How long will we keep your information for?**

We keep and dispose of all records in line with our record retention schedule; information about this is at <https://www.derby.gov.uk/retention-schedule/>. We will comply with the Data Protection 2018

**What security precautions in place to protect the loss, misuse or alteration of your information?**

We are strongly committed to data security and will take reasonable and appropriate steps to protect your personal information from unauthorised access, loss, misuse, alteration or corruption. We have put in place physical, electronic, and managerial procedures to safeguard the information you provide to us. However, we cannot guarantee the security of any information you transmit to us. We recommend that you take every precaution to protect your personal information.

**Keeping your data up to date**

We want to ensure any information we hold is accurate. You can help us by promptly informing us of any changes to the information we hold about you.

**Under 13s**
