Who we are?

How do we collect information from you?

We collect information from you when you visit www.derby.gov.uk; also when you contact us in writing, speak to us on the phone, by email or any other type of electronic communication, or talk to us face to face.

What types of information do we collect from you?

We collect different categories of information about you, depending on the service you want from us and/or the reason why we need to process information relating to you. This could be personal information (for example your name and address), or other more sensitive data that we would only collect and use in very particular circumstances that are set out in law.

Details of information obtained from third parties?

We sometimes receive personal information from Derby Homes, NHS Healthcare Professionals and GP surgeries and Waste Contractors.

How is your information used?

We may use your information to:

- process payments or charge relating to services offered by all teams,
- to carry out our obligations arising from any contracts entered into by you and us;
- we may notify you of changes to our services or to inform you of new services in accordance with our legitimate business interests, you can opt out at any time by contacting gardenrecycling@derby.gov.uk
- send you communications which you have requested and that may be of interest
- fulfil our legal obligations and statutory duties under the Environmental Protection Act 1990 and Road Traffic Act 1998
- fulfil our public tasks in line with the public interest as set out in the Environmental Protection Act 1990 and the Clean Neighbourhood and Environment Act 2005

Research & Statistics

Anonymised & Pseudonymised data may be used for research & Statistical purposes. Any Data collected may be used for research and statistical purposes that are relevant and compatible with the purpose that the data was collected for.

Who has access to your information?

We may share your information with the following third parties for the reasons detailed;

- Other Council Directorates and Derby Homes
- Where we have your consent to do so we may share information with elected members
- Where necessary and in accordance with our legitimate interests we may share information with Derby Homes.
- Statutory agencies, such as the Police, National Fraud Authority We may share your information with statutory agencies in line with our legal obligations and/or in completion of our public tasks
- Doctor and/or medical professional for clinical waste service delivery.
- Relevant insurance companies regarding road traffic accidents.

We will not sell or rent your information to third parties. We will not share your information with third parties for marketing purposes.

What are your rights in relation the personal data we process?

Access – you can request copies of any of your personal information that is held by the Council. **Rectification** – you can ask us to correct any incorrect information.

Deletion – you can ask us to delete your personal information. The Council can refuse to delete information if we have a lawful reason to keep this.

Portability – you can ask us to transfer your personal data to different services or to you.

Right to object or restrict processing – you have the right to object to how your data is being used and how it is going to be used in the future.

Right to prevent automatic decisions – you have the right to challenge a decision that affects you that has been made automatically without human intervention, for example an online form with an instant decision.

How long will we keep your information for?

We keep and dispose of all records in line with our record retention schedule; information about this is at https://www.derby.gov.uk/retention-schedule. We will comply with the Data Protection 2018.

What security precautions in place to protect the loss, misuse or alteration of your information?

We are strongly committed to data security and will take reasonable and appropriate steps to protect your personal information from unauthorised access, loss, misuse, alteration or corruption. We have put in place physical, electronic, and managerial procedures to safeguard the information you provide to us. However, we cannot guarantee the security of any information you transmit to us. We recommend that you take every precaution to protect your personal information.

We want to ensure any information we hold is accurate. You can help us by promptly informing us of any changes to the information we hold about you.
